Vietnam vet feels like "Rocky" after liver transplant

Stuart - Bob Strasser is making a remarkable recovery for someone who was sent home to die from liver cancer just a few months ago. "I can't stop smiling, it's unbelievable" a jubilant Strasser said after receiving a liver transplant Jan. 12. "I feel like doing a Rocky" he said, referring to the triumphant scene on the steps of the Philadelphia Art Museum in the first movie. "I got a perfect match." Wounded and decorated in the Vietnam war the 50 year old former Marine—"Actually, I'm 44 days old," he quipped— was close to dying when he got word a liver was available. He credits Vito Rao retired physician in Boca Raton for getting him through the process required to get onto a transplant waiting list. Rao is the National Service Officer for the Marine Corps League Southeast division and heard about Strasser through a fellow leaguer. "I tried to determine what could be done for him," Rao said during a recent visit with Strasser. "I knew he was pretty destitute at the time, he had no visible means of income, he was as close to desperate as you can get." Strasser, who was on 100% Social Security disability, yet he had no health insurance. "My experience told me that when someone has 100% disability and is receiving SSI benefits, he automatically qualifies for Medicare, in spite of his age." Rao said. So they applied for Medicare insurance, and got it. Strasser's \$300,000.00 liver transplant was covered, and he went through the system to get onto the waiting list. Both fault the VA for not playing more of an advocacy role in Strasser's case, but Rao said it was "horrendous" that Strasser was given another appointment six months down the road at the Riviera Beach VA office. "That was like a death sentence, because frankly, he couldn't survive six months," he said. "He was approximately two weeks from just terminating." Rao wants to help others who don't know where to turn. "There are some very fine organizations that do a lot of work in this area." Rao said. "But a lot of people don't know how to find them." Rao also said the public needs to be more aware of just how desperately organ donations

are needed. He said Strasser was one of the lucky ones. His donor was a 71 year-old Tampa man "who had heart trouble, and a perfect liver." HAROLD WILSON, 76, a Marine who won the Medal of Honor in the Korean War, died Sunday in West Columbia S.C., of lung cancer. Mr. Wilson was cited for heroism during an enemy attack April 23-24 1951. Although wounded in an arm, a leg, his head and shoulder, he rallied troops, delivered ammunition and administered first aid as attackers swarmed his platoon's position. When the final attack was repulsed at dawn, he walked unassisted a half-mile to an aid station.

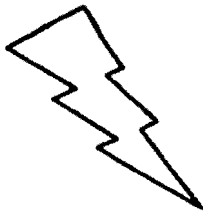
