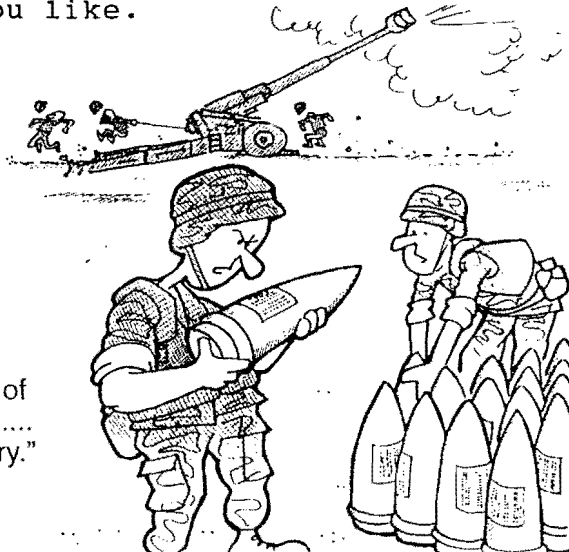

**CONVENTION CALLED FOR ORLANDO AREA IN FALL**

**DRAFT BY LAWS SUBMITTED**

A draft copy of the proposed Department By Laws was given to each attendee at the Department meeting in St Cloud and mailed to those not attending. The following **CHANGES** were enacted:

Article III, SECTION 2., Para. a), last sentence shall read: "Appointed officials shall not have a vote, **except when holding a position normally requiring election.**"

Article III, SECTION 7., Para. b), shall read: "Failure to attend **two (2) consecutive** Department meetings without just cause.

PLEASE REVIEW THE DEPT. BY LAWS WITH YOUR CHAPTER MEMBERS IN PREPARATION FOR ADOPTION.
