### **Beware of GI life insurance hoax.**

An insurance hoax that has created administrative problems for the Dept. of Veterans Affairs for more than 40 years has resurfaced in the Miami newspapers and probably will hit your area soon. The article contains what appears to be a legitimate offer telling veterans they are entitled to a dividend on the GI insurance they had while in the service. The VA Regional Office & Insurance

Center in Philadelphia reports veterans and active duty personnel nationwide have received fliers, including return forms, from groups or individuals offering veterans assistance in applying for the dividends or in answering questions they might have. Fees range from \$2 to \$15 for each request. The articles falsely claim dividends from veterans life insurance are available to any veteran who applies. The articles go on to claim specific dollar amounts a veteran would receive, depending on the length of service. The phony applications and fliers claim the dividends have been recently authorized by Congress. In fact, there is no such dividend for veterans who do not keep their insurance in force, nor a rebate for active duty personnel. No such legislation has been approved or proposed by Congress. As in the past, the hoax applications are unwittingly printed in magazines, newspapers and newsletters, or distributed in handbills. The hoax has caused wasted efforts by thousands of veterans, active duty personnel and dependants, and has generated needless labor and mailing expense by the VA. Legitimate insurance dividends are automatically paid, usually on the anniversary date of the policy, to approximately 3 million veterans with active policies in 4 GI life insurance programs. No application is needed to receive the dividend payment. The VA is determined to stop the perpetrators of this hoax, who are trying to make a profit at the expense of veterans. Use this handy checklist to ensure that this information is readily available. It is recommended that these documents be placed in a safe location such as a safety deposit box. By taking these precautions, you will be doing yourself and your family a great favor.

- \_\_\_\_\_ VA Claim Number
- \_\_\_\_\_ VA Office where Veterans Records are Maintained

Documents Required To Apply For Benefits. A common problem is that the widow(er) does not have, or cannot find the documents required to apply for benefits. The burden of proof of entitlement to various benefits is the individual applicants responsibility. Prepare yourself - obtain now what you may require later. Check the following listing.

**Birth Certificate(s)**

For retiree - spouse and dependant children.

**Marriage Certificate(s)**

To include any previous marriages of the retiree and/or spouse.

**Divorce Decree(s)**

To include any previous divorce of the retiree and/or spouse.

**Changes in Name**

Court order changing name of retiree, spouse or dependant children.

**Discharge Certificate**

DD Forms 214 covering all periods of active service.

**Retirement Orders**

**A Death Certificate must accompany any claim filed**

**for benefits and entitlements after the death of a retired member**

These documents are required for Social Security benefits, VA entitlements, SBP/RSFPP claims, Retired Pay, life insurance claims, vehicle registration, property deeds, joint bank accounts, etc.

The Court of Veterans Appeals (COVA) was established in 1968 solely that millions of veterans and their dependants would have the right to judicial review of decisions from the VA, yet none of the present judges ever represented veterans in an advocacy role before being appointed to the court. All six of the judges currently sitting on the court are former government employees. In fact, no veterans lawyer has ever served on the court. The result is that the point of view of veterans' advocates is not articulated during the deliberations of the "veterans court" Veterans may rightly ask whether they are receiving truly independent judicial review when one side, the government, has the exclusive power to appoint judges and uses that power to monopolize the court by excluding veterans' advocates from the bench.

## **Notification of Annual Assessment**

A proposal by the Executive Council that a levy of one dollar (\$1.00) per member be assessed against each Chapter to help provide operating expenses for the department was approved by the membership at the annual business meeting on 25 Oct. 97.

An operating budget not to exceed \$2500.00 in expenditures by the department was also adopted at this meeting. These expenditures are to be for, but not limited to, copying, mailing, telephone and other incidental costs such as sympathy flowers, but will *not normally* cover travel, lodgings, meals or other expenses of any officers in the performance of their duties. The by-laws allow previously authorized travel expenses, which has not, and probably will not, occur without a huge increase in our income.

The Dept. Officers wish to bring to the attention of the chapter members that this assessment against slightly over 500 members, as determined by a compilation at the meeting, covers only twenty percent of the budget.

Support of department fund raising efforts is essential Please support your department.

It was decided arbitrarily that the assessment would be based on the number of members claimed by your chapter on 1 Jan. 98. **IT IS BASED ON THE HONOR SYSTEM.** We suggest that the assessment be paid out of your chapter treasury and recovered as you see fit. **THIS ASSESSMENT IS DUE BEFORE 1 MARCH 1998**
