As of this writing, we have received a total of \$23,032.85 for the Wounded Warrior Fund plus approximately \$16,000 sent in by the Deland Skydiving Association where I worked as the President of Florida, KWVA, for three days

I cannot thank you enough for your support of the truly deserving thousands of men and women that are wounded in our current military conflicts.

I trust that every member has had a chance to read the account of Marine Sergeant Merlin German that was distributed at the Fall Council meeting and you will see why I'm so passionate about the Wounded Warrior Project.

Public law 110-254 – June 30, 2008 is the title assigned to the Charter for the KWVA. The complete text of the bill can be downloaded from the KWVA National website [www.kwva.org] along with commentary by the principal legislators and our then President Louis Dechert. The text is in Portable Document Format (PDF) a program which can be downloaded for free from the Adobe web site.

The most significant item was probably:
Article 120105 POWERS "The corporation has only those powers provided in its bylaws and articles of incorporation filed in each State in which it is incorporated."

The September Council Meeting

Highlights of the Fall Council Meeting at Spring Hill featured the transmittal of checks in the amount of \$21,598.06 to President Balzer for his Wounded Warrior Program primarily from the Spring Hill Community and Dr. Singh.

Judge Advocate

The Judge Advocate, Hank Butler reported that the KWVA now has a National Charter issued by Congress and that would probably mean changes in the near future in Chapter and Department Bylaws

Quartermaster

The Quartermaster, Dick Garfield, announced that he would be resigning effective with the January Council meeting. Eddie Ko, Korean Liaison representative, updated the assembly on the political situation in North Korea. He indicated the possibility of a citizen's revolt.

Historian

As of the 2009 Convention, we will be looking for a new Historian inasmuch as Kelly Goodblood has relocated to Maine and will no longer be able to help us.

Lost Chapters

Two chapters, Chapter 159 and Chapter 293 were dropped from the State rolls. The Pensacola Chapter disbanded and were advised to send in their charter. Chapter 159 has not responded for two years to any communication and has not paid any dues. After repeated attempts, the Department of Florida has suspended Chapter 159 as part of the Department and has notified KWVA National of our actions.

A raffle for the Swiss Army Mountain Rifle (Circa 1918) in mint condition was shown by Bill McCraney and Chapter Presidents were reminded that the limited tickets were sent out previously by the Secretary. The drawing will be part of the Annual Convention at Crystal River.
